## Wisconsin Parental Choice Program

---



**Lamb of God Ev. Lutheran School is excited to participate in the Wisconsin Parental Choice Program for the 2019-2020 school year!**

Application period: **February 1 - April 20, 2019**

Eligibility:

1. The student must reside in the State of Wisconsin but outside of the city of Milwaukee and the Racine Unified School District.
2. The family income must be at or below the amount listed on table 2 for WPCP which can be found at [dpi.wi.gov/choice](http://dpi.wi.gov/choice) by clicking on the *Income Limits 2019-20* link.

Application:

1. **Only online applications are accepted.** Parents/guardians must visit [dpi.wi.gov/choice](http://dpi.wi.gov/choice) to access the Online Parent Application. An Application Process Presentation is available on the site to help with the application. Interested parents may also attend a presentation at Lamb of God Ev. Lutheran School (LoG) February 6 at 6:30 p.m. for help with the application process. ***Early application provides LoG time to verify your residency and income to DPI.***
2. **Proof of Residency** - Parents/guardians must provide proof of residency documentation to LoG. Allowed Residency Documentation may be found at [dpi.wi.gov/choice](http://dpi.wi.gov/choice) by clicking on the *Allowed Residency* link.
3. **Income Documentation** - Parents/guardians must also provide income documentation to LoG which must be selected on the online application. There are two methods of verification from which to choose:

**DOR (Department of Revenue) method** - If the DOR has completed its review of the parent(s)' 2018 Wisconsin income tax return, it will generally use the 2018 Wisconsin income tax return. Otherwise, the 2017 Wisconsin income tax return will generally be used. If the parent(s) has received a Wisconsin tax refund for 2018, the 2018 income will likely be used. Applicants should consider using the DPI method if they do not qualify based on their 2017 income. FAQ's may be accessed at [dpi.wi.gov/choice](http://dpi.wi.gov/choice) by clicking on the *Department of Revenue (DOR) Income Determination Method FAQ* link.

**DPI (Department of Public Instruction) method** - Parents/guardians will answer a series of income questions on the application. Hard copies of income documentation must be provided to LoG for verification. All information will be kept confidential.

Eligibility:

1. The student must reside in the State of Wisconsin within the city of Milwaukee.
2. The family income must be at or below the amount listed on table 1 for MPCP which can be found at [dpi.wi.gov/choice](http://dpi.wi.gov/choice) by clicking on the *Income Limits 2019-20* link.
